

# Parent Permission & Financial Responsibility Form



READ, SIGN & RETURN TO TROOP LEADER/TROOP COOKIE MANAGER

**As a parent/guardian of a Girl Scout participating in the 2019 Girl Scout Cookie Program, I agree to:**

**Abide by all start dates & deadlines established by the Troop and Girl Scouts of Greater Atlanta**

- I will honor the program start date of January 1, 2019. At this time my Girl Scout can begin to take orders using the Girl Order Card and sending emails through the Digital Cookie Program. Girl Scout Cookie Booths begin Monday, February 18, 2019.
- I will turn in orders and money to the Troop by the predetermined date(s).
- I will pick up all earned rewards for my Girl Scout during the designated timeframe set by the Troop Leader/ Cookie Manager. *Note: No adjustments/exchanges to rewards will be made by council after May 1, 2019.*

**Provide proper supervision and adult guidance to my Girl Scout**

- I will assist my Girl Scout in making prompt delivery of cookies to her customers.
- I will supervise my Girl Scout while online and monitor her Digital Cookie sales activity.

**Be responsible for all cookies and money entrusted to me**

- I will sell all items at their listed cost (no tax or fees).
- I will turn in money collected from customers to the Troop Leader/Cookie Manager on a regular basis and get a signed receipt for cookies received and/or money paid to the Troop to have on hand should there be a discrepancy.
- I understand that cookies cannot be returned and that I am financially responsible for all cookies for which I have possession. If cookies and/or money are lost or stolen, I understand that I am responsible for replacement.
- I acknowledge that failure to pay for all cookies received is unacceptable, and by not paying my balance in full by the deadline designated by the troop, I will cause my Girl Scout's earned girl rewards to be withheld until the amount due has been satisfied. This could also result in collection and/or legal action taken by the Troop and/or Girl Scouts of Greater Atlanta. All fees charged in conjunction with this process will then become my responsibility, including but not limited to attorney fees, court costs, and collection fees.
- I acknowledge that there is a standard manufacturer's warranty for all electronics my Girl Scout earns in the program. As a parent/guardian, I am eligible to purchase an extended warranty on any electronic item, if I choose.
